### Invesco EUR Government and Related Green Transition UCITS ETF (the "Fund") A sub-fund of Invesco Markets II plc (the "Umbrella Fund") Acc (ISIN: IE0007BT2BH8) (the "Share Class")

The Fund is managed by Invesco Investment Management Limited, part of the Invesco Group.

## Objectives and Investment Policy

- The Fund is an actively-managed Exchange-Traded Fund (ETF), which aims to provide the performance of the European government bond market by investing in an actively managed portfolio of government and government-related bonds that also factors certain environmental, social, and corporate governance ("ESG") criteria into the portfolio construction and maximises exposure to Green Bonds subject to exposure and liquidity considerations.
- In order to achieve the investment objective, the Fund will generally invest in a portfolio of euro denominated government and government-related bonds predominantly issued by European issuers with an investment grade rating. The Fund may invest up to 30% of its assets in bonds denominated in currencies other than euro. The Fund will only invest in bonds from developed market issuers, unless an issuer is from the European Economic Area (EEA) in which case an emerging market issuer is eligible. The Fund may invest up to 30% of its assets in issuers not from the EEA. Securities are selected by the Investment Manager based on three criteria: 1) compliance with the Fund's ESG policy. Bonds issued by governments and corresponding agencies and local authorities are eligible for inclusion in the portfolio if the relevant country has ratified and implemented into national legislation (a) the eight fundamental conventions identified in the International Labour Organisation's Declaration on Fundamental Rights and Principles at Work, and (b) at least half of the 18 core International Human Rights Treaties. The Investment Manager also applies exclusionary criteria which excludes countries based on non-conformity with international treaties and assessments by third-party non-profit organisations. Government-owned issuers that are not government guaranteed are excluded based on their involvement in controversial business activities and/or controversies (as more fully defined in the ESG policy of the Fund; 2) maximising exposure to Green Bonds subject to specific exposure and liquidity considerations, with a minimum proportion of Green Bonds in the portfolio set at 20% of the Fund's invested assets (excluding cash holdings); and 3) the overall ability of the Fund's portfolio to meet certain ex ante tracking error targets relative to the Benchmark.
- The Fund is an Article 8 Fund (it promotes environmental and/or social characteristics) for the purposes of Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability related disclosures in the financial services sector ("SFDR").
- The Fund's shares are listed on one or more Stock Exchange(s). Investors can buy or sell shares daily through an intermediary directly or on Stock Exchange(s) on which the shares are traded. In exceptional circumstances other investors will be permitted to redeem their shares directly from Invesco Markets II plc in accordance with the redemption procedures set out in the prospectus, subject to any applicable laws and relevant charges.
- The Fund's base currency is EUR.
- Dividend Policy:** This Share Class does not pay you income, but instead reinvests it to grow your capital, in line with its stated objectives.
- Net Asset Value:** This is calculated daily and the Fund is open for subscriptions and redemptions on each day the Trans-European Real-Time Gross Settlement Express Transfer (TARGET-2) System is open. Please refer to the prospectus for further information.
- The Benchmark:** The Bloomberg Euro Aggregate Treasury Index may be used for comparison purposes only. The Fund is actively-managed and is not constrained by a benchmark.

## Other Risks

- General Investment Risk:** The value of investments, and income from them, can go down as well as up and you may not get back the full amount you invested.
- Credit risk:** The creditworthiness of the debt the Fund is exposed to may weaken and result in fluctuations in the value of the Fund. There is no guarantee the issuers of debt will repay the interest and capital on the redemption date. The risk is higher when the Fund is exposed to high yield debt securities.
- Interest Rate Risk:** Changes in interest rates will result in fluctuations in the value of the Fund.
- Green bond risk:** The Fund invests in Green Bonds which means the Fund will be more affected by the performance of Green Bonds than a fund that is more diversified across the bond market. The market for Green Bonds and related regulation is evolving. The current accepted market standard definitions of "green" may change over time and in such event, the Fund may change the definition of green bonds that is applied by the Fund.
- Securities lending:** The Fund may be exposed to the risk of the borrower defaulting on its obligation to return the securities at the end of the loan period and of being unable to sell the collateral provided to it if the borrower defaults.
- Derivatives risk:** This fund may use derivatives for investment purposes. The use of such complex instruments may impact the magnitude and frequency of the fluctuations in the value of the fund.
- Environmental, Social and Governance Risk:** The Fund intends to invest in securities of issuers that manage their ESG exposures better relative to their peers. This may affect the Fund's exposure to certain issuers and cause the Fund to forego certain investment opportunities. The Fund may perform differently to other funds, including underperforming other funds that do not seek to invest in securities of issuers based on their ESG ratings.

- \*Currently, the Fund is not exercising its entitlement to apply entry and exit charges.
- The **ongoing charge** is based on the fee paid to the Manager. The Manager is responsible for discharging from its fee, costs attributable to the Investment Manager, Administrator, Depositary as well as the Operational Expenses incurred by the Fund. It excludes portfolio transaction costs except in the case of an entry or exit charge paid by the Fund when buying or selling shares/units in another fund.
- Because the Fund is an ETF, investors will typically only be able to buy or sell shares in the secondary market. Accordingly, investors may incur brokerage and / or transaction fees in connection with their dealings. Investors may also bear the costs of "bid-ask" spreads; meaning the difference between the prices at which shares can be bought and sold. You should discuss these fees and costs with your broker before you invest, as they may reduce the amount of your initial investment and the amount you receive on disposal.
- The Fund may engage in securities lending, whereby 90% of the revenues arising from securities lending will be returned to the Fund and 10% of the revenues will be retained by the securities lending agent.
