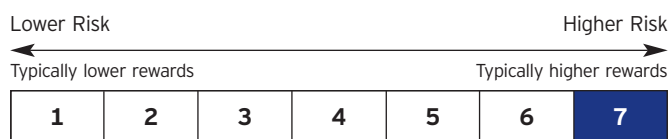
### Invesco Wind Energy UCITS ETF (the "Fund") A sub-fund of Invesco Markets II plc (the "Umbrella Fund") Acc (ISIN: IE0008RX29L5) (the "Share Class")

The Fund is managed by Invesco Investment Management Limited, part of the Invesco Group.

## Objectives and Investment Policy

- The Fund is a passively-managed Exchange-Traded Fund (ETF), which aims to achieve the net total return performance of the WilderHill Wind Energy Index (the "Index")<sup>1</sup>, less fees, expenses and transaction costs, thereby taking an approach that seeks to invest in companies whose innovative technologies focus on advancing wind energy and enabling its use, hence facilitating a transition to a lower carbon economy.
- To achieve the investment objective the Fund will, as far as possible and practicable, hold all the securities in the Index in their respective weightings.
- The Fund's shares are listed on one or more Stock Exchange(s). Investors can buy or sell shares daily through an intermediary directly or on Stock Exchange(s) on which the shares are traded. In exceptional circumstances investors will be permitted to redeem their shares directly from Invesco Markets II plc in accordance with the redemption procedures set out in the prospectus, subject to any applicable laws and relevant charges.
- The Fund is an Article 9 Fund (it has a sustainable investment objective) for the purposes of Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability related disclosures in the financial services sector ("SFDR").
- The Fund's base currency is USD.
- **Dividend Policy:** This Share Class does not pay you income, but instead reinvests it to grow your capital, in line with its stated objectives.
- **Net Asset Value:** This is calculated daily and the Fund is open for subscriptions and redemptions on each day the United States Federal Reserve System is open. Please refer to the prospectus for further information.
- **The Index:** The Index tracks the performance of global companies whose innovative technologies focus on advancing wind energy and enabling its use. It is composed of companies focused on improving wind turbines and blades, providing materials used in wind energy, modernising the grid, facilitating greater wind energy deployment or expanding its use; it includes companies involved in onshore and offshore wind energy. Companies are excluded if they are deemed by the Index provider (using data provided by Sustainalytics) to be involved in activities which have adverse impacts on societies and ecosystems from an environmental, social and governance standpoint. Companies are then assessed by the Index provider to determine whether they are eligible for inclusion as a component of the Index based on its involvement in business activities that focus on wind energy as a sub-category of new energy innovation within the following sectors (as defined by the Index provider) and without significant fossil fuel exposure: 1) Smarter Grids in Wind Energy; 2) Wind Farms; 3) Wind Materials and 4) Wind Innovation. Securities must also meet certain liquidity and tradability criteria to be eligible for inclusion in the Index. The index is calculated by equally weighting each security. The Index is rebalanced quarterly.

## Risk and Reward Profile



- The Share Class is in risk category 7 due to the rises and falls of its price or simulated data in the past.
- As the Share Class' risk category has been calculated using historical data, it may not be a reliable indication of the Share Class' future risk profile.

## Other Risks

- **General Investment Risk:** The value of investments, and income from them, can go down as well as up and you may not get back the full amount you invested.
- **Stock Connect Risk:** The Fund may use Stock Connect to access China A Shares traded in Mainland China. This may result in additional liquidity risk and operational risks including settlement and default risks, regulatory risk and system failure risk.
- **Emerging market risk:** Emerging markets are generally more sensitive to economic and political conditions and less liquid than developed markets.
- **Equity Risk:** The value of equities and equity-related securities can be affected by a number of factors including the activities and results of the issuer and general and regional economic and market conditions. This may result in fluctuations in the value of the Fund.
- **Securities lending:** The Fund may be exposed to the risk of the borrower defaulting on its obligation to return the securities at the end of the loan period and of being unable to sell the collateral provided to it if the borrower defaults.
- **Small Companies:** As this fund invests primarily in small companies, investors should be prepared to accept a higher degree of risk than for an ETF with a broader investment mandate.
- **Clean energy risk:** Investments into the clean energy sector are considerably exposed to investment trends focused on environmental factors and may have sensitivities towards ESG related government regulation and tax implications.

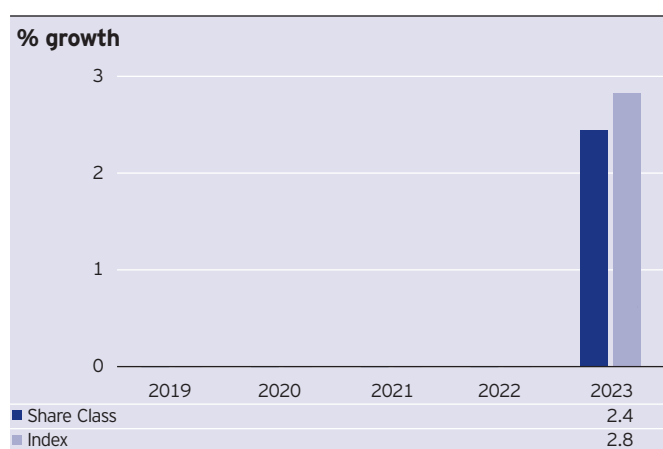
## Charges

- \*Currently, the Fund is not exercising its entitlement to apply entry and exit charges.
- The **ongoing charge** is based on the fee paid to the Manager. The Manager is responsible for discharging from its fee, costs attributable to the Investment Manager, Administrator, Depositary as well as the Operational Expenses incurred by the Fund. It excludes portfolio transaction costs except in the case of an entry or exit charge paid by the Fund when buying or selling shares/units in another fund.
- Because the Fund is an ETF, investors will typically only be able to buy or sell shares in the secondary market. Accordingly, investors may incur brokerage and / or transaction fees in connection with their dealings. Investors may also bear the costs of "bid-ask" spreads; meaning the difference between the prices at which shares can be bought and sold. You should discuss these fees and costs with your broker before you invest, as they may reduce the amount of your initial investment and the amount you receive on disposal.
- The Fund may engage in securities lending, whereby 90% of the revenues arising from securities lending will be returned to the Fund and 10% of the revenues will be retained by the securities lending agent.
