FUND OVERVIEW

The Fund aims to achieve a return on your investment, through a combination of capital growth and income on the Fund's assets, which reflects the return of the Bloomberg MSCI December 2028 Maturity EUR Corporate ESG Screened Index, the Fund's benchmark index.

KEY BENEFITS

- Provides exposure to investment grade, fixed rate, Euro denominated corporate bonds which mature between 01/01/2028 and 15/12/2028.
- The Fund is a defined term fund and shareholders in the Fund on 31 December 2028 will have their Shares redeemed on 1 January 2029 when all the bonds invested in in the fund are expected to have matured.
- Applies screens which exclude issuers that are involved in the following business lines/ activities: tobacco production, nuclear weapons, civilian firearms production and controversial weapons, thermal coal, generation of thermal coal, oil sands, conventional weapons and weapons systems/ components/ support systems/ services.








GLOSSARY

Yield to Maturity: Yield to Maturity (YTM) is the discount rate that equates the present value of bond's cash flows with its market price (including accrued interest). The fund YTM is the weighted average of fund's individual bond holding YTMs based upon Net Asset Value ('NAV'). The measure does not include fees and expenses. For callable bonds, YTM is the Yield-to-Worst.

Effective Duration: Effective duration is a measure of a fund's interestrate sensitivity. Put simply, the longer a fund's duration, the more sensitive the fund is to shifts in interest rates. So a fund with a duration of 10 years is twice as volatile as a fund with a five-year duration.
