Investment objective

The investment objective of the Fund is to deliver a return based on the performance of an Index it may either “track” or “replicate”.

Fund performance, tracking difference and tracking error

In “tracking” the performance of an Index, the Investment Manager does not necessarily seek to replicate the composition of the Index (i.e. the full list of constituents in the same or substantially the same proportions as they are weighted within the Index). Instead, the Investment Manager is simply aiming to track the performance of the Index. The Investment Manager may use one or more techniques (including a combination thereof) to track the performance of an Index including (i) optimisation/sampling techniques whereby direct investments are made in physical assets and (ii) the use of FDIs such as OTC Swaps whereby a financial counterparty is engaged contractually to provide the return of the relevant Index. Optimising techniques enable a Fund to invest in (or gain exposure to) either a representative sample of Index constituents and/or assets unrelated to the Index constituents in each case where the relevant Investments (when taken together) resemble the risk and return characteristics of constituents of the Index or of the Index as a whole.

These techniques will also enable the Investment Manager to reflect anticipated changes in an Index in the Fund's portfolio (resulting in for example, Index constituents and corporate actions being reflected in the Fund's portfolio, Index constituents being sold or purchased in anticipation of those constituents being included or removed from the relevant Index, or weightings of Index constituents (vis-à-vis the actual Index composition) being varied).

In “replicating” the performance of an Index, the Investment Manager will seek to invest in (or gain exposure to) all Index constituents in the same or substantially the same proportions as they are weighted within the Index.

“Tracking error” can be defined as the volatility of the difference between the return of an Index Fund which tracks/replicates an Index versus the return of the relevant Index which it tracks or replicates, whereas “tracking difference” can be defined as the total return difference between such an Index Fund and the relevant Index which it tracks or replicates over a certain period of time.

Unless otherwise stated, an Index Fund is not expected to track the performance of its Index at all times with perfect accuracy and there can be no assurance that any Index Fund will achieve any particular level of accuracy in tracking or replicating an Index. Each Index Fund that seeks to track or replicate an Index is, however, expected to provide investment results that, before fees and expenses are applied, generally correspond to the price and yield performance of its Index.

Cash management, efficient portfolio management techniques including securities lending, transaction costs from rebalancing and currency hedging can have an impact on tracking difference. Importantly, these impacts can be either positive or negative depending on the underlying circumstances.

Sub-fund outlook and commentary

Global X U.S Infrastructure Development UCITS ETF

America's infrastructure received a C- grade from the American Society of Civil Engineers' (ASCE) in 2021. It requires about US\$2.6tr of additional spending over the next 10 years. President Joe Biden US\$1.2tr infrastructure bill signed into law in November 2021, will deliver US\$550bn of new federal investments in America's infrastructure over five years, including bridges, roads, nation's broadband, water and energy systems. The Infrastructure Investment and Jobs Act provides a massive tailwind for the US infrastructure Development theme.

Global X CleanTech UCITS ETF

Around 75% of warming comes from a heightened concentration of carbon dioxide in the atmosphere.¹ With 2020 tying 2016 for being the hottest year on record, emissions mitigation efforts are more needed than ever.² We believe heightened private investment in CleanTech on the back of global decarbonisation commitments is an indicator of accelerating adoption.

Global X Renewable Energy UCITS ETF

Renewable energy adoption is accelerating as declining underlying technology costs for solar photovoltaic (PV) and on/offshore wind generation incentivise a transition away from fossil fuels. With almost 90% of energy consumption still coming from traditional sources, we expect adoption to accelerate further amid continued cost competitiveness, technological advancements, and supportive decarbonisation policies.

Global X Autonomous & Electric Vehicles UCITS ETF

Global electric vehicle (EV) sales came in at just under 1.1m vehicles for Q1 2021 (+125% year-over-year) and could reach 4.4m by the end of the year (+40% YoY).³ While EVs still cost more than internal combustion engine (ICE) vehicles to purchase, cheaper batteries are contributing to declining costs and the total cost of ownership for EVs is cheaper than that of ICEs. In our view, supportive government policy and shifting automaker priorities will help bring prices down further and increase EV penetration.

Global X FinTech UCITS ETF

FinTech is continuing to disrupt the way we transact and access financial services in 2021. Last year's accelerated shift to a cashless economy has continued into this year, with some estimating that global mobile payment adoption will reach just below 20% by year's end.⁴ Cryptocurrencies have also greater acceptance among consumers, driving large FinTech companies to scale or initiate related-business operations.

Global X Genomics & Biotechnology UCITS ETF

Genomic sequencing volumes are increasing in 2021 on the back of increased COVID-19 surveillance efforts. While in the short-term this should boost sequencing, we think this is just the beginning of the runway. COVID-19 presents a case study for how useful genomic information can be for monitoring population health and developing interventions. Moving forward, we think it will be an essential pillar of the health care industry.

Global X Robotics & Artificial Intelligence UCITS ETF

Robotics & Artificial Intelligence (AI) are seeing increased investment and adoption as companies seek to mitigate the risk presented by future pandemic-like events and recognise the benefits of automation. We expect this to continue at a strong pace through the end of 2021, specifically driven by supply chain reshoring and technological advancements in AI.

Global X Video Games & Esports UCITS ETF

Video game streaming viewership is continuing to grow in 2021, breaking the records set at the height of the pandemic. In our view, this reflects that increased video game consumption is not just here to stay, but is poised for continued growth. Positive streaming numbers both solidify the case for video games as an entertainment medium for spectators and imply demand for the video games that are being streamed.

Global X Telemedicine & Digital Health UCITS ETF

Telemedicine utilisation is ticking back upward in 2021, continuing the trend seen at the end of last year following a summer drop-off. Patients are drawn to the convenience of virtual health care, while providers are continuing to solidify their virtual infrastructure. We expect utilisation to expand as technological advancement, industry growth, and supportive reimbursement policies help drive demand.

Global X Cloud Computing UCITS ETF

Cloud computing is continuing to play an important role in 2021. Though lockdown measures have been lifted for the most part, many companies are embracing hybrid in-office/work-from-home arrangements that will require continued investment in cloud resources. Outside of this, we think the longer-term shift toward centralised store/compute is still playing out as a meaningful share of these functions remain outside of the cloud.

Global X E-commerce UCITS ETF

E-commerce's share of retail sales has remained above pre-pandemic levels across all product areas in 2021. We expect to see further penetration across all categories, with previously lagging areas like food/beverage, auto, and health/beauty gaining the most share. Recent real estate trends give credence to this forward-looking view, with strength in net leasing of warehouse space and weakness in retail space.

Global X Cybersecurity UCITS ETF

Cyberattacks are continuing to evolve alongside technology. Increased virtualization and the proliferation of connected devices and digital assets create new targets for cybercriminals who hope to exploit new vulnerabilities. Much of these technologies experienced rapid adoption in a short time period, increasing vulnerability. We expect cybersecurity companies to play an active role in reducing these threats as disruption normalises.

Global X Internet of Things UCITS ETF

Among many things, the pandemic exposed the underlying vulnerabilities of global supply chains, notably the semiconductor industry. Meanwhile, disruptive technologies in fast-growing industries like 5G, AI, cloud computing, and electric & autonomous vehicles are driving up long-term demand for semiconductors. Policymakers around the world are exploring options to re-shore semiconductor manufacturing and reduce dependency on other countries, providing a tailwind to this theme.

Global X Clean Water UCITS ETF

Sub-optimal water management practices, alongside neglected water infrastructure development and maintenance, has led access to clean water to become a dire global challenge. Global X are starting to see a shift to a more sustainable model, led by government policy, technological innovation, and growing consumer and public health advocacy.

Global X Data Center REITS & Digital Infrastructure UCITS ETF

Digital infrastructure sits at the intersection of numerous disruptive trends, from increasing connectivity through the growth of 5G and the internet of things, to the rise of big data and artificial intelligence, and the transition to software delivered seamlessly through the cloud. Global X believes that such infrastructure is therefore essential to 21st century growth and can play a multi-faceted role in investors' portfolios that could offer income and growth characteristics. Its exposure to Real Estate also positions it well in an inflationary environment.

Global X Lithium & Battery Tech UCITS ETF

The electric vehicle (EV) supply chain is reaching an inflection point as consumers, original equipment manufacturers (OEMs) and governments accelerate the shift away from internal combustion engines (ICEs) and towards battery-powered vehicles. Major traditional automobile manufacturers like GM and Ford are investing billions to electrify their model ranges over the next 10 to 15 years. To meet growing EV demand, battery production must expand substantially.

Global X Copper Miners UCITS ETF

By February 2021, copper had risen above US\$4.00/pound, nearly doubling March 2020's lows. Copper prices are positively correlated to inflation, and the metal is historically one of the best performing assets during inflationary periods. The rise of cleantech and renewables projects globally, as well as infrastructure development, represent significant growth opportunities for copper, with substantial amounts of copper required to rebuild modern infrastructure and energy systems.

1. Nature of operations

The ICAV was registered in Ireland, registration number C435449, pursuant to the Irish Collective Asset-management Vehicles Act 2015 (the “ICAV Act”) on 20 July 2020 and authorised by the Central Bank of Ireland (the “Central Bank”) as an Undertaking for Collective Investment in Transferable Securities pursuant to the European Communities (Undertaking for Collective Investment in Transferable Securities) Regulations 2011 (S.I. No 352 of 2011), and the Central Bank (Supervision and Enforcement) Act 2013 (Section 48(1)) (Undertakings for Collective Investments in Transferable Securities) Regulations 2019 (collectively the “UCITS Regulations”).

The ICAV is organised in the form of an umbrella fund with segregated liability between sub-funds. Each sub-fund has a distinct portfolio of investments and the investment objective and policy of each sub-fund is formulated by the investment manager. At 31 December 2021, the following funds (“Sub-Funds”) were in operation:

2. Basis of preparation and significant accounting policies

(a) Statement of compliance

The unaudited condensed semi-annual financial statements are prepared in accordance with IAS 34 ‘Interim Financial Reporting’, the ICAV Act and the UCITS Regulations. This report presents financial statements for Global X Video Games & Esports UCITS ETF, Global X Telemedicine & Digital Health UCITS ETF, Global X Genomics & Biotechnology UCITS ETF, Global X U.S. Infrastructure Development UCITS ETF, Global X Cloud Computing UCITS ETF, Global X E-commerce UCITS ETF, Global X FinTech UCITS ETF, Global X CleanTech UCITS ETF, Global X Robotics & Artificial Intelligence UCITS ETF, Global X Cybersecurity UCITS ETF, Global X Autonomous & Electric Vehicles UCITS ETF, Global X Internet of Things UCITS ETF, Global X Copper Miners UCITS ETF, Global X Renewable Energy Producers UCITS ETF, Global X Clean Water UCITS ETF, Global X Lithium & Battery Tech UCITS ETF and Global X Data Center REITs & Digital Infrastructure UCITS ETF as at 31 December 2021. This report presents comparative financial statements as at 30 June 2021 on the Statement of Financial Position and related notes for Global X Video Games & Esports UCITS ETF and Global X Telemedicine & Digital Health UCITS ETF. Comparative financial statements for the period ended 31 December 2020 are not available and therefore comparative numbers for 30 June 2021 have been presented on the Statement of Comprehensive Income, Statement of Changes in Net Assets Attributable to Holders of Redeemable Participating Shares, Statement of Cash Flows and related notes for Global X Video Games & Esports UCITS ETF and Global X Telemedicine & Digital Health UCITS ETF.

(b) Basis of preparation

The financial statements are presented in United States Dollars (“USD” or “US\$”). The financial statements have been prepared under the going concern and under the historical cost convention, as modified by the revaluation of financial assets at fair value through profit or loss.

The preparation of financial statements in conformity with IFRS requires management to make judgements, critical accounting estimates and assumptions that affect the application of policies and the reported amounts of assets and liabilities, income and expense. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period or in the period and future periods if the revision affects both current and future periods.

All references to net assets throughout this document refer to net assets attributable to holders of redeemable participating shares.

(c) Changes in relevant accounting standards

Standards and Amendments to existing standards effective during the period

There are no standards, amendments to standards or interpretations that are effective for the period under review that have a material effect on the financial statements of the Sub-Funds.

Standards, amendments and interpretations that are not yet effective for the period and not early adopted

A number of new standards, amendments to standards and interpretations are effective for annual periods beginning after 1 January 2022, and have not been applied in preparing these financial statements. None of these are expected to have a material effect on the financial statements of the Sub-Funds.

(d) Significant accounting policies

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied for the period presented, unless otherwise stated.

i. Foreign currency translation

Functional and presentation currency

Functional currency is the currency of the primary economic environment in which the Sub-Funds operate. When indicators of the primary economic environment are mixed, management uses its judgement to determine the functional currency that most faithfully represents the economic effect of the underlying transactions, events and conditions. Management have determined that the functional currency of the Sub-Funds is USD (“US\$”). Investor subscriptions and redemptions are received and paid in the currency of the relevant Share Class which is predominantly in USD. The expenses incurred by the Sub-Funds (including management fees, custodian fees and administration fees) are also denominated and paid mostly in USD.

Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign currency assets and liabilities are translated into the functional currency using the exchange rate prevailing at the period end date.

Foreign exchange gains and losses arising from translation are included in the Statement of Comprehensive Income.

Net gain on foreign exchange translation

Foreign exchange gains and losses relating to cash and cash equivalents are presented in the Statement of Comprehensive Income within ‘Net gains/(losses) on financial assets and liabilities at fair value through profit or loss’.

Foreign exchange gains and losses relating to the financial assets and liabilities carried at fair value through profit or loss are presented in the Statement of Comprehensive Income within ‘Net gains/(losses) on financial assets and liabilities at fair value through profit or loss’.

ii. Investments

Classification

In accordance with IFRS 9, the Sub-Funds classify investments as financial assets or financial liabilities at fair value through profit or loss.

All of the Sub-Funds’ financial assets and liabilities designated at fair value through profit or loss are financial instruments that are classified as held for trading and are considered managed investments. Their performance is evaluated on a fair value basis in accordance with the Sub-Funds’ investment strategy.

All other financial assets and liabilities including cash, cash equivalents, receivables and payables are classified as being measured at amortised cost. Measurement at amortised cost takes into account any premium or discount on acquisition as well as transaction costs and fees that are an integral part of the effective interest rate. All financial assets measured at amortised cost are short term in nature and the application of the expected credit loss model does not impact the carrying amounts of these financial assets as they approximate their fair values under IFRS 9.

ii. Investments (continued)

Recognition, derecognition and measurement

Regular purchases and sales of investments are recognised on the trade date - the date on which each Sub-Fund commits to purchase or sell the investment. Financial assets and financial liabilities at fair value through profit or loss are initially recognised at fair value. Transaction costs are expensed as incurred in the Statement of Comprehensive Income. Financial assets are derecognised when the rights to receive cash flows from the investments have expired or the Sub-Fund has transferred substantially all risks and rewards of ownership.

Subsequent to initial recognition, all financial assets and financial liabilities at fair value through profit or loss are measured at fair value. Realised and unrealised gains and losses arising from changes in the fair value of the 'financial assets or financial liabilities at fair value through profit or loss' category are presented in the statement of comprehensive income within net gains/losses on financial assets and liabilities at fair value through profit or loss in the financial period in which they arise.

In accordance with IFRS 9, the Company applies the 'expected credit loss' ("ECL") model when determining if financial assets are subject to impairment. This impairment model applies to financial assets measured at amortised cost and an assessment is required to determine if an ECL is required. The Company has determined that the application of IFRS 9's impairment requirements results in no ECL impairment as the cash and cash equivalents, receivables and payables are short-term in nature.

Fair value estimation

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value of financial assets and liabilities traded in active markets (such as publicly traded derivatives) are based on quoted market prices at the close of trading on the reporting date. In circumstances where the last traded price is not within the bid-ask spread, management will determine the point within the bid-ask spread that is most representative of fair value.

If a quoted market price is not available on a recognised market or from a broker/dealer for non-exchange traded financial instruments, the fair value of such investment shall be estimated with care and in good faith by a competent professional person, body, firm or corporation (appointed for such purpose by the Board of the ICAV) and such fair value shall be determined on the basis of the probable realisation value of the investment.

If the Investment Manager considers that the methods of valuation set out above do not provide a fair valuation of a particular asset, it may ask for the fair value to be estimated with care and in good faith by a competent person appointed by the Board of the ICAV and approved for the purpose by the Depositary.

As at 31 December 2021, the fair values of all of the Sub-Funds' investments were determined by reference to quoted market prices.

iii. Cash and cash equivalents

Cash and cash equivalents includes cash in hand, deposits held at call with banks and other short-term investments in an active market with original maturities of three months or less.

iv. Expenses

Expenses are recognised on an accrual basis.

v. Income

Interest income is recognised on a time-proportionate basis using the effective interest method.

vi. Redeemable participating shares

All redeemable shares issued by the ICAV provide the investors with the right to require redemption for cash at the value proportionate to the investor's share in the Company's net assets at the redemption date. The participating shares which comprise the capital of the ICAV are in substance a liability of each Sub-Fund to shareholders under IAS 32.

In accordance with the Prospectus, the ICAV is contractually obliged to redeem shares at the net asset value per share.

vii. Distribution policy

It is intended to declare dividends in respect of the Share Classes identified as "distributing" Classes of the Sub-Funds. Distributions in respect of these Classes will be declared on each distribution date, semi-annually, in each year provided that such dates are not business days. The distribution may comprise net income (if any) of the relevant Sub-Fund.

It is not the current intention of the Directors to declare dividends in respect of the Share Classes identified as "accumulating" Classes. The income and earnings and gains of the accumulating classes will be accumulated and reinvested in the Sub-Funds.

viii. Subscriptions receivable

Subscriptions receivable, if any, are reported on the Statement of Financial Position and relate to unsettled subscriptions.

ix. Redemptions payable

This relates to the amount requested in the redemption notice becoming fixed. This generally may occur either at the time of the receipt of a valid and approved notice, or on the last day of a fiscal period, depending on the nature of the request. As a result, redemptions paid after the end of the period, but based upon period end capital balance are reflected as redemptions payable.

x. Securities sold receivable

Securities sold receivable, if any, are reported on the Statement of Financial Position and relate to unsettled sales of the equity trades.

xi. Securities purchased payable

Securities purchased payable, if any, are reported on the Statement of Financial Position and relate to unsettled purchases of equity trades.

Bank overdrafts are repayable on demand and form an integral part of the cash management of the Sub-Funds.

3. Taxation

Under current law and practice the ICAV qualifies as an investment undertaking as defined in Section 739B of the Taxes Consolidation Act 1997, as amended. On that basis, it is not chargeable to Irish tax on its income or gains.

Notwithstanding the above, Irish tax may arise on the happening of a “chargeable event”. A chargeable event includes:

- Any distribution payments made to shareholders by the ICAV in respect of their shares;
- Any encashment, redemption, cancellation or transfer of shares;
- The holding of shares at the end of each eight year period beginning with the acquisition of such shares.

No Irish tax will arise on the ICAV in respect of chargeable events in respect of:

- A shareholder who is neither Irish resident nor ordinarily resident in Ireland for tax purposes, at the time of the chargeable event, provided appropriate valid declarations in accordance with Section 739D of the Taxes Consolidation Act, 1997, as amended, are held by the ICAV or the ICAV has been authorised by the Irish Revenue to make gross payments in the absence of appropriate declarations under the ICAV with the necessary signed statutory declarations; and
- Certain exempted Irish tax resident shareholders who have provided the ICAV with the necessary signed statutory declarations.

Capital gains, dividends and interest received by the ICAV may be subject to taxes, including withholding taxes in the countries in which the issuers of investments are located, which may be reflected in the Net Asset Value (“NAV”) of the ICAV. Dividend and interest income has been recognised gross in the Statement of Comprehensive Income, with withholding taxes recognised separately. Such taxes may not be recoverable by the ICAV or its shareholders.

The ICAV has evaluated the tax positions and has concluded that there are no significant tax positions requiring recognition, measurement or disclosure in the financial statements. Tax penalties and interest, if any, would be accrued as incurred and would be classified as tax expense in the Statement of Comprehensive Income. During the period ended 31 December 2021, the ICAV did not incur any interest or penalties.

4. Share capital

The share capital of the ICAV shall at all times equal the Net Asset Value of the ICAV. The Directors are empowered to issue up to 500 billion Shares of no par value in the ICAV at the Net Asset Value per Share on such terms as they may think fit. There are no rights of pre-emption upon the issue of Shares in the ICAV. The Subscriber Shares do not participate in the assets of any Sub-Fund. The ICAV reserves the right to redeem some or all of the Subscriber Shares provided that the ICAV at all times has a minimum issued share capital to the value of €300,000.

Each of the Shares entitles the Shareholder to participate equally on a pro rata basis in the dividends and net assets of a Sub-Fund attributable to the relevant Class in respect of which they are issued, save in the case of dividends declared prior to becoming a Shareholder. The Subscriber Shares' entitlement is limited to the amount subscribed and accrued interest thereon.

The proceeds from the issue of Shares shall be applied in the books of the ICAV to the relevant Sub-Fund and shall be used in the acquisition on behalf of the relevant Sub-Fund of assets in which the Sub-Fund may invest. The records and accounts of each Sub-Fund shall be maintained separately.

The Directors reserve the right to redesignate any Class from time to time, provided that Shareholders in that Class shall first have been notified by the ICAV that the Shares will be redesignated and shall have been given the opportunity to have their Shares redeemed by the ICAV, except that this requirement shall not apply where the Directors redesignate Shares in issue in order to facilitate the creation of an additional Class.

Each of the Shares entitles the Shareholder to attend and vote at meetings of the ICAV and of the relevant Class of a Sub-Fund represented by those Shares. No Class confers on the holder thereof any preferential or pre-emptive rights or any rights to participate in the profits and dividends of any other Class or any voting rights in relation to matters relating solely to any other Class.

Any resolution to alter the Class rights of the Shares requires the approval of three quarters of the Shareholders of the Shares represented or present and voting at a general meeting duly convened in accordance with the Instrument of Incorporation.

The Instrument of Incorporation of the ICAV empowers the Directors to issue fractional shares in the ICAV. Fractional shares may be issued and shall not carry any voting rights at general meetings of the ICAV or of any Sub-Fund or Class and the Net Asset Value of any fractional Share shall be the Net Asset Value per Share adjusted in proportion to the fraction.

It is intended that all but two of the Subscriber Shares will be redeemed by the ICAV at their Net Asset Value on the Dealing Day on which the first issue of Shares is effected after the Initial Offer Period. 5. Fees and Expenses

TER Fees

All of the following fees and expenses payable in respect to the Share Classes of the Sub-Funds are paid as one single fee, which will not exceed an amounts described listed below. This is referred to as the total expense ratio or "TER". The TER is calculated and accrued daily from the Net Asset Value of each Sub-Fund and payable monthly in arrears to the ICAV at the rate set out below. 7. Fair value measurement

As the Sub-Funds' investments are classified as financial assets at fair value through profit or loss, the carrying value of the Sub-Funds' investments is a reasonable approximation of fair value. The Sub-Funds accounting policy on fair value measurements is discussed in Note 2(d). The Sub-Funds measure fair values, as defined by IFRS 13 'Fair Value Measurement' ("IFRS 13"), using the following fair value hierarchy that reflects the significance of the inputs used in making the measurements:

- Level 1: Quoted market price (unadjusted) in an active market for an identical instrument.
- Level 2: Valuation techniques based on observable inputs, either directly (i.e. as prices) or indirectly (i.e. derived from prices). This category includes instruments valued using: quoted market prices in active markets for similar instruments; quoted prices for identical or similar instruments in markets that are considered less than active; or other valuation techniques where all significant inputs are directly or indirectly observable from market data.
- Level 3: Valuation techniques using significant unobservable inputs. This category includes all instruments where the valuation technique includes inputs not based on observable data and the unobservable inputs have a significant effect on the instrument's valuation. This category includes instruments that are valued based on quoted prices for similar instruments where significant unobservable adjustments or assumptions are required to reflect differences between the instruments.

Fair values of financial assets that are traded in active markets are based on quoted market prices or dealer price quotations. For all other financial instruments, each Sub-Fund determines fair values using valuation techniques as described above.

The Directors are satisfied that there are arrangements in place to ensure that the obligations set out in the Central Bank UCITS Regulations are applied to all transactions with connected persons and transactions with connected persons entered into during the financial period complied with the obligations set out in the Central Bank UCITS Regulations.

Shareholders should note that not all connected parties as defined by IAS 24 ‘Related Party Disclosures’ are deemed related parties as defined by the Central Bank UCITS Regulations.

9. Transaction Costs

Transaction costs are incremental costs that are directly attributable to the acquisition, issue or disposal of a financial asset or financial liability. An incremental cost is one that would not have been incurred if the entity had not acquired, issued or disposed of the financial instrument.

10. Significant events during the reporting period

The outbreak of the Coronavirus (COVID-19), declared by the World Health Organisation as a global pandemic on the 11 March 2020, continues to impact many aspects of daily life and the global economy. Travel, movement and operational restrictions have been implemented by many countries. In some cases, lockdowns have been applied – in varying degrees – to reflect further waves of COVID-19. While these may imply a new stage of the crisis, they are not unprecedented in the same way as the initial impact. The pandemic and the measures taken to tackle COVID-19, including the development and roll out of vaccines globally, continue to affect economies and public equity markets globally. The success of vaccine programs are expected to have a major impact on the speed and nature of economic recovery but the timing and form of the recovery remains uncertain, particularly with the emergence of new strains of COVID-19. The Directors are continuing to utilise business continuity and resilience processes with the objective of mitigating the impact of COVID-19.
