
Objectives:

The sustainable investment objective of the Fund is to replicate the performance of the Foxberry SMS USA Environmental Impact USD Net Total Return Index while positively impacting climatic and environmental challenges (the "Index"). The Fund is passively managed.

Intended Retail Investor:
