Objectives:

The sustainable investment objective of the Fund is to replicate the performance of the Foxberry SMS Global Sustainable Infrastructure USD Net Total Return Index (the "Index") which provides exposure to companies supporting global infrastructure development in a way that balances economic, environmental and social objectives. The Fund is passively managed.
