Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to reflect the performance of the J.P. Morgan India Government Fully Accessible Route (FAR) Bonds Index (index). DESCRIPTION OF INDEX: The index aims to reflect the performance of fixed rate and zero coupon, Indian Rupee denominated government bonds issued by the Indian central government that have been made eligible for investment to nonresidents under the fully accessible route (FAR). In addition, these bonds are subject to minimum maturity and issue size requirements. To be eligible for the index, constituents must meet minimum liquidity criteria including the availability of pricing, availability for trading and reasonable transaction costs linked to CALCULATION INDEX REBALANCING, replication. AND ADMINISTRATION: The index is a total return gross index which means that coupon payments are reinvested in the index gross of taxes. The index is reviewed and rebalanced monthly and is administered by J.P. Morgan Securities LLC. INVESTMENT POLICY: To achieve the aim, the fund will attempt to replicate the


