Objectives and investment policy

The fund is passively managed. The aim is for your investment to track the performance, before fees and expenses, of the MSCI Europe Low Carbon SRI Leaders Index (index). The index is based on the MSCI Europe Index (Parent Index), which is designed to reflect the performance of certain shares in large and medium-sized listed companies in developed market countries in Europe. In order to be eligible for inclusion in the index, companies must be eligible for inclusion in the Parent Index and must display high environmental, social and governance (ESG) performance and low current and potential carbon exposure relative to their peers. The constituent selection process is based on three sets of rules applied sequentially: (i) Low Carbon Transition Risk Assessment Rules, used to assess a company's current risk exposure and its efforts to manage the risks and opportunities presented by the low carbon transition, (ii) High ESG Performance Selection Rules which are used to assess the ESG performance of constituents of the Parent Index and to exclude companies involved in industries with a high potential for negative ESG impact or companies which have been involved in severe ESG related controversies, and (iii) Low Carbon Emissions Rules, whereby, if current selected carbon metrics of the index are insufficiently reduced compared to the Parent Index, securities with the highest such carbon metrics are removed until the current carbon metrics of the index are sufficiently reduced as compared with the Parent Index. The remaining securities are then weighted by their free-float adjusted market capitalisation and are

also subject to a relative weight cap against their weight in the Parent Index. The index is calculated on a total return net basis which means that all dividends and distributions by the companies are reinvested in the shares after tax. The index is reviewed and rebalanced on a quarterly basis. The index is calculated in Euros on a daily basis. To achieve the aim, the fund will attempt to replicate the index, before fees and expenses, by buying all or a substantial number of the securities in the index. The fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of financial contracts (derivatives). The fund may also engage in secured lending of its investments to certain eligible third parties subject to certain ESG criteria to generate additional income to offset the costs of the fund. Certain information (including the latest share prices of the fund, indicative net asset values, full disclosure on the composition of the fund's portfolio and information on the index constituents) are available on your local DWS website or at www.Xtrackers.com. Transaction costs and taxes, unexpected fund costs and market conditions such as volatility or liquidity issues may affect the ability of the fund to track the index. The anticipated level of tracking error in normal market conditions is 1 per cent. The currency of the fund is EUR. Returns and gains are not distributed but are reinvested in the fund. You may request the redemption of shares generally on a daily basis.

Risk and reward profile



The calculation of the risk and reward profile is based on historical data that cannot be used as a reliable indicator for the future risk profile. The following risks could be of particular significance for the fund: The fund will attempt to replicate the performance of the index less costs, but your investment is not expected to match the performance of the index precisely. The ESG screening criteria are embedded within the index selection process, which seeks to exclude securities issued by companies involved in certain activities. The company is solely relying on the activities conducted by and information provided by the administrator of the index and MSCI ESG Research LLC for the ESG screening. ESG information from third-party data providers may be incomplete, inaccurate or unavailable. As a result, there is a risk that the index administrator may incorrectly assess a security or issuer, resulting in the incorrect inclusion or exclusion of a security in the index. The index is rules-based and is not capable of being adjusted to take into account changing market circumstances. The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

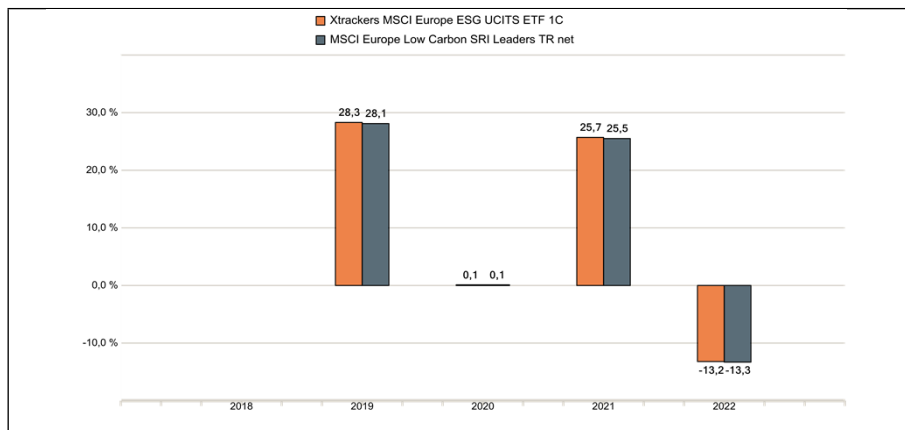
