# **Key Information Document**



#### **Purpose**

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

#### **Produc**

iShares MSCI Japan SRI UCITS ETF (the "Fund"), USD Dist (the "Share Class"), ISIN: IE00BGDQ0V72, is authorised in Ireland and manufactured by BlackRock Asset Management Ireland Limited (the "Manager") which is part of the BlackRock, Inc group.

The Manager is authorised in Ireland and regulated by the Central Bank of Ireland (the "CBI") and the CBI is responsible for supervising the Manager in relation to this Key Information Document.

#### What is this product?

**Type:** The Fund is a sub-fund of iShares IV plc, an umbrella company incorporated in Ireland, authorised by the Central Bank of Ireland as a Undertaking for Collective Investment in Transferable Securities ("UCITS"). The Fund is a UCITS exchange-traded fund, a UCITS ETF.

**Term:** The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

#### **Objectives**

- The Fund aims to achieve a return on your investment, through a combination of capital growth and income on the Fund's assets, which reflect the return of the MSCI Japan SRI Select Reduced Fossil Fuel Index, (the Index).
- The Fund, is passively managed and aims to invest in the equity securities (e.g. shares) that make up the Index.
- The Index measures the performance of a sub-set of equity securities (e.g. shares) issued by Japanese companies within the MSCI Japan Index (Parent Index) with higher environmental, social and governance (ESG) ratings than other sector peers within the Parent Index, based on a series of exclusionary and ratings based criteria. Companies may be excluded from the Index if they are involved with controversial/conventional weapons, nuclear weapons/power, civilian firearms, tobacco, alcohol, gambling, adult entertainment, genetically modified organisms, thermal coal, oil sands, and unconventional/conventional oil and gas extraction / power generation, as further detailed in the "Benchmark Index" section of the Prospectus.
- The remaining companies are rated by the index provider based on their ability to manage their ESG risks and opportunities and are given a
  MSCI ESG rating which determines their eligibility for inclusion.
- The Fund may obtain limited exposure to securities considered not to satisfy these ESG criteria.
- The Fund will adopt a best-in-class approach to sustainable investing, this means that it is expected that the Fund will invest in the best issuers from an ESG / socially responsible investment ("SRI") perspective (based on the ESG or SRI criteria of the Index) within each relevant sector of activities covered by the Index.
- Eligible constituents within each Global Industry Classification Standard ("GICS") sector are ranked by the index provider and are weighted based on their free float adjusted market capitalisation as further discussed in the Prospectus.
- The Index targets 5% issuer exposure capping. In order to reduce the risk of non-compliance with the 5% threshold due to market movements, the weight of each issuer is capped at 4.5% at the point of Index construction and at each rebalancing.
- The Fund intends to replicate the Index by holding the equity securities which make up the Index in similar proportions to it...
- The investment manager may use financial derivative instruments (FDIs) to help achieve the Fund's investment objective. FDIs may be used for direct investment purposes.
- The price of equity securities fluctuates daily and may be influenced by factors affecting the performance of the individual companies issuing the equities, as well as by daily stock market movements, and broader economic and political developments which in turn may affect the value of your investment.
- The relationship between the return on your investment, how it is impacted and the period for which you hold your investment is considered below (see "How long should I hold it and can I take my money out early?").
- The depositary of the Fund is State Street Custodial Services (Ireland) Limited.

- Your shares will be distributing shares (i.e. income will be paid on the shares annually).
- Your shares will be denominated in US Dollar, the Fund's base currency.
- The shares are listed and traded on various stock exchanges. In normal circumstances, only authorised participants may buy and sell shares directly with the Fund. Investors who are not authorised participants (e.g. select financial institutions) can generally only buy or sell the shares on the secondary market (e.g. via a broker on a stock exchange) at the then prevailing market price. The value of the shares are related to the value of the underlying assets of the Fund, less costs (see "What are the costs?" below). The prevailing market price at which the shares trade on the secondary market may deviate from the value of the Shares. Indicative net asset value is published on relevant stock exchanges websites.

Intended retail investor: The Fund is intended for retail investors with the ability to bear losses up to the amount invested in the Fund (see "How long should I hold it and can I take my money out early?").

Insurance benefits: The Fund does not offer any insurance benefits.

## What happens if BlackRock Asset Management Ireland Limited is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary, State Street Custodial Services (Ireland) Limited (the "Depositary"). In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). As a shareholder of the Fund you would not be able to make a claim to the UK Financial Services Compensation Scheme or any other scheme about the Fund in the event that the Fund is unable to pay out.

#### What are the costs?
