

Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to reflect the performance of the Bloomberg MSCI USD Liquid Investment Grade Corporate SRI PAB Index (index). DESCRIPTION OF INDEX: The index aims to reflect the performance of certain types of tradable debt (bonds) issued by companies which are denominated in US Dollars. The index aims to comply with the minimum standards of the EU Parisaligned Benchmark (EU PAB) Regulation by setting an initial 50% decarbonization of absolute greenhouse gas (GHG) emissions relative to the standard Bloomberg USD Liquid Investment Grade Corporate Index, followed by an annual 7% decarbonization trajectory of absolute GHG emissions. In addition, the index will exclude bonds issued by companies which fail to meet certain environmental, social and governance (ESG) criteria. The composition the index is rebalanced monthly. On each rebalancing date, specific rules are applied to determine which bonds are eligible for inclusion, which include; minimum time to maturity, amount outstanding, ESG considerations, and a minimum 'investment grade' credit rating from major ratings agencies. INDEX REBALANCING, CALCULATION AND ADMINISTRATION: The index is administered by Bloomberg Index Services Limited (index administrator). The index is calculated on a total return basis which

means that the payments from coupons are reinvested in the Reference Index. INVESTMENT POLICY: To achieve the aim, the fund will i) attempt to replicate the index, before fees and expenses, by buying a portfolio of securities that may comprise the constituents of the index or other unrelated investments as determined by DWS entities and ii) enter into financial contracts (derivatives) which attempt to reduce the effect of exchange rate fluctuations between the currency of the fund's assets and the currency of your shares. The fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of derivatives. FURTHER INFORMATION: Certain information (including the latest share prices of the fund, indicative net asset values, full disclosure on the composition of the fund's portfolio and information on the index constituents) are available on your local DWS website or at www.Xtrackers.com. Transaction costs and taxes, unexpected fund costs and market conditions such as volatility or liquidity issues may affect the ability of the fund to track the index. The anticipated level of tracking error in normal market conditions is 1 per cent. The currency of the fund is USD. Returns and gains are not distributed but are reinvested in the fund. You may request the redemption of shares generally on a daily basis.

Risk and reward profile

ESG information from third-party data providers may be incomplete, inaccurate, or unavailable. As a result, there is a risk that the index administrator may incorrectly assess a security or issuer, resulting in the incorrect inclusion or exclusion of a security in the index. Whilst the index seeks to ensure alignment with all EU PAB requirements at each rebalance date, between these rebalances limits may be breached and relevant targets may not be reached. DERIVATIVES RISK: The fund may use derivatives to i) try to manage its investments more efficiently, and ii) try to reduce movements in currency exchange rates between the currency of the fund's assets and the currency of the fund's shares. 
