

#### **Investment Overview**

Franklin STOXX Europe 600 Paris Aligned Climate UCITS ETF (the "Fund") provides exposure to European large and mid-capitalisation stocks which are aligned to the transition to a low carbon economy. The Fund is classified as Article 8 under the EU Sustainable Finance Disclosure Regulation. The Fund is passively managed and seeks to track the performance of the STOXX® Europe 600 Paris- Aligned Benchmark Index (Net Return) (the "Index") as closely as possible, regardless of whether the Index level rises or falls.

Standard Deviation: Measure of the degree to which a fund's return varies from the average of its previous returns.
