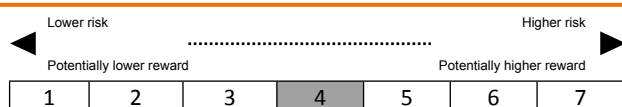

Objectives and investment policy

The fund is passively managed. The aim is for your investment to reflect the performance of the Markit iBoxx EUR Liquid High Yield 1-3 Index (index). The index reflects the performance of the largest and the most liquid sub-investment grade corporate bonds denominated in Euro and issued by companies based both inside and outside of the Eurozone. The composition of the index is reviewed and rebalanced on a monthly basis. For new bonds to be included in the index, they must, on the relevant rebalancing date, have a minimum remaining time to maturity of at least one year and up to three years. The bonds can have a fixed or floating rate of interest and must be rated less than Baa3/BBB- by major rating agencies. The index is administered by IHS Markit Benchmark Administration Limited. To achieve the aim, the fund will invest in transferable securities and enter into financial contracts

(derivatives) with one or more swap counterparties relating to the transferable securities and the index, in order to obtain the return on the index. Certain information (including the latest share prices of the fund, indicative net asset values, full disclosure on the composition of the fund's portfolio and information on the index constituents) are available on your local DWS website or at www.Xtrackers.com. Transaction costs and taxes, unexpected fund costs and market conditions such as volatility or liquidity issues may affect the ability of the fund to track the index. The anticipated level of tracking error in normal market conditions is 1 per cent. The currency of the fund is EUR. The fund distributes up to four times per annum. You may request the redemption of shares generally on a daily basis.

Risk and reward profile



The calculation of the risk and reward profile is based on historical data that cannot be used as a reliable indicator for the future risk profile. This risk indicator is subject to changes; the classification of the fund may change over time and cannot be guaranteed. Even a fund that is classified in the lowest category (category 1) does not represent a completely risk-free investment. The fund is classified in category 4 because its share price fluctuates and the likelihood of both losses and gains may therefore be relatively high. The following risks could be of particular significance for the fund: The fund does not invest directly in the components of the index and its returns will be dependent on the performance of the bonds and/or cash deposits and the performance of the derivatives used. The fund will enter into a derivative with one or more counterparties. If any of the counterparties fails to make payment (for example, it becomes insolvent) this may result in your investment suffering a loss. DWS entities and related companies may act in several roles in relation to the fund such as distributor and management company which may involve conflicts of interest. The fund is not

guaranteed and your investment is at risk. The value of your investment may go down as well as up. The index is rules-based and is not capable of being adjusted to take into account changing market circumstances. An investor may be negatively affected by, or may not benefit from, the lack of such adjustments. The derivative used to gain exposure to the index may be adjusted to reflect certain expenses in relation to taxes and/or buying, selling, borrowing, financing or custody costs. These replication costs may result in the fund and your investment suffering a loss. Investors should be aware that, due to there being no sector allocation cap, the index may become more concentrated to a particular sector and/or sectors. The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

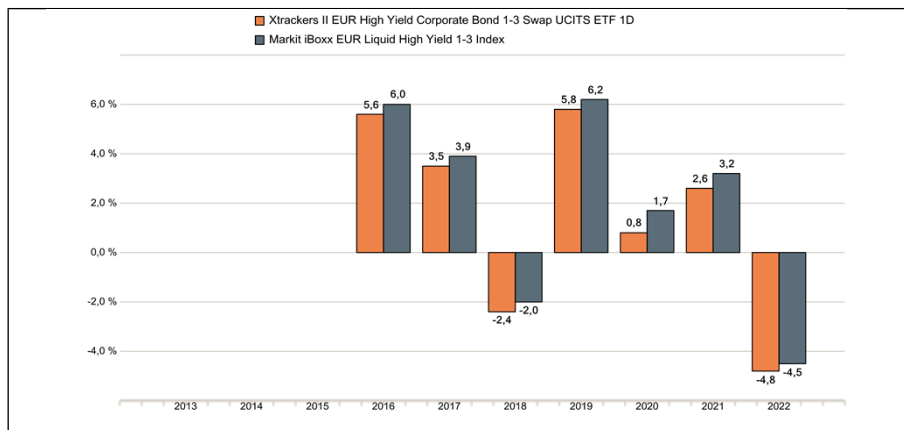
