### What is this product?

Type: Shares of a Sub-Fund of Lyxor Index Fund, a SICAV.

**Term:** The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: The Fund is an index-tracking UCITS passively managed.

The investment objective of the Fund is to track both the upward and the downward evolution of the STOXX® Europe 600 Personal & Households Goods Net Total Return index (net dividends reinvested) (the Benchmark Index") denominated in Euros and representative of the performance of shares in large companies in the personal and household goods sector in European countries, while minimizing the volatility of the difference between the return of the Fund and the return of the Benchmark Index (the "Tracking Error").

The anticipated level of Tracking Error in normal market conditions is indicated in the prospectus.

The Fund seeks to achieve its objective via indirect replication by entering into an over-the-counter swap contract (financial derivative instrument, the "FDI").

The Fund may also invest in a diversified portfolio of international equities, whose performance will be exchanged against the performance of the benchmark Index via the FDI.



### **RISK INDICATOR**

Order Schedule: Orders to buy and/or sell (redeem) shares received and accepted by 04:00 PM on any Luxembourg business day are ordinarily processed on the same day (using the valuation of that day).
