# **Objective and Investment Policy**

AMUNDI MSCI USA ESG UNIVERSAL SELECT seeks to replicate, as closely as possible, the performance of the MSCI USA ESG Universal Select Index (Total return index). This sub-fund has exposure to large and mid-cap companies of the US equity markets with robust ESG characters (including those that show recent improvement of their rating), while reducing the weight of those companies who lag behind their industry peers in terms of ESG quality and excludes companies involved in Tobacco and Thermal Coal sectors.



# **Description of the Index**

MSCI USA ESG UNIVERSAL SELECT is an equity index based on the MSCI USA Index ("Parent Index"), representative of the large and mid-cap securities of the US market. The index aims to represent the performance of a strategy that increase the exposure compared to the Parent Index to companies with both a robust ESG profile as well as a positive trend in improving that ESG profile. The methodology aims at adjusting the constituents' free-float market capitalisation weights based upon certain environmental, social and governance ("ESG") metrics.





### Carbon footprint

This indicator measures the portfolio's carbon emissions in metric tonnes of carbon equivalent (tCO2e) per euro million invested.

This is an indicator of the emissions generated by investment in this portfolio.

# Definition of scopes:

- Scope 1 : all emissions that arise directly from sources that are owned or controlled by the company.
- Scope 2: all indirect emissions generated by the purchase or production of electricity, steam or heat.
- Scope 3: all other indirect emissions, both upstream and downstream in the value chain. To ensure the robustness of the data, in this report we have chosen to use only part of scope 3, i.e. upstream emissions linked to first-tier suppliers. First-tier suppliers are those with which the company has a strong relationship and on which it can exercise direct influence.

Source: The carbon emissions data is supplied by Trucost. It corresponds to companies' annual emissions expressed in tCO2e, which covers the six greenhouse gases defined in the Kyoto protocol whose emissions are converted into global warming potential (GWP) in CO2 equivalent.
