Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to reflect the performance of the iBoxx EUR Sovereigns ESG Tilted Index (index). DESCRIPTION OF INDEX: The index aims to reflect the performance of EUR denominated sovereign bond issues with adjusted weights, which meet certain minimum environmental, social and governance (ESG) standards, by allocating higher weights to countries with a favorable Country-Risk score and reducing weights of countries with a less favorable Country-Risk score. ESG CRITERIA: Bonds which breach the following ESG standards, amongst others, are excluded: (i) All issuers with a Sustainalytics Country-Risk Category of 'Severe" will be excluded from the index. The Sustainalytics Country-Risk Score is used to tilt the index weights by allocating higher weights to countries with a favorable Country-Risk score and allocating lower weights to countries with a less favorable Country-Risk score; and (ii) All issuers must have a Freedom House Global Freedom Status of "Free" or "Partly Free". INDEX REBALANCING, CALCULATION AND ADMINISTRATION: The index is reviewed and rebalanced monthly, where the aggregate weight for any country will be capped at 35% and any excess will be distributed to

all the remaining bonds on a pro rata basis. The index is calculated on a total return basis. This means that all interest payments received from bonds are reinvested in the index. INVESTMENT POLICY: To achieve the aim, the fund will attempt to replicate the index, before fees and expenses, by buying a portfolio of securities that may comprise the constituents of the index or other unrelated investments as determined by DWS entities. The fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of derivatives. FURTHER INFORMATION: Certain information (including the latest share prices of the fund, indicative net asset values, full disclosure on the composition of the fund's portfolio and information on the index constituents) are available on your local DWS website or at www.Xtrackers.com. The anticipated level of tracking error in normal market conditions is 1 per cent. The currency of the fund is EUR. The fund distributes up to four times per annum. You may request the redemption of shares generally on a daily basis.


