DESCRIPTION OF INDEX: The companies making up the index are large and medium sized companies based on the combined value of a company's readily available shares as compared to other companies. A company's weighting on the index INDEX depends on its relative size. REBALANCING, CALCULATION AND ADMINISTRATION: The index is calculated on a total return net basis which means that all dividends and distributions by the companies are reinvested in the shares after tax. The index is reviewed and rebalanced at least quarterly. As securities lending revenue sharing does not increase the costs of running the fund, this has been excluded from the composition of costs.
